The Greater West Portal Neighborhood Association (GWPNA) is seeking this participatory budget grant to support our efforts to launch a neighborhood disaster preparedness program. Since 1974, GWPNA has been advocating for the health and well-being of our community. GWPNA has a long history of partnering with City Departments and Agencies to address issues such as traffic safety, crime, and other quality of life issues.

Like most communities, West Portal neighbors were deeply concerned by what transpired during the recent fires in Sonoma and Napa Counties. Even more recently, fires have blazed across Southern California close to Los Angeles. Disproportionately the people who have died were residents who were older, less mobile and didn't have the immediate support of family and friends in the few short moments they had to evacuate and get out of harm's way.

As stewards of our community, GWPNA began researching what other neighborhoods are doing to prepare for the next disaster and came across the work being done by the Miraloma Park Improvement Club (MPIC) and the Merced Extension Triangle Neighborhood Association (METNA). Both neighborhoods have partnered with the City's Neighborhood Empowerment Network (NEN) and deployed a system called the Empowered Communities Program (ECP). The ECP helps communities create a resilience action plan that provides residents, local businesses, non-profits, faith-based organizations, and the community at large with a game plan to get prepared as well as a platform to work together for the first 72 hours after a disaster and help arrives.

We hope to replicate the success that MPIC and METNA have had in getting the resources and training that residents need so that when the next "big one" hits, we'll be ready to help ourselves and our neighbors and keep West Portal a healthy, happy and thriving community.

The name of the project is **Resilient West Portal**.

From intense winter storms that knock out power and cause flooding to lethal heatwaves that took the lives of District 7 residents, the changing climate is putting our vulnerable residents under incredible stress; and that doesn't include the inevitable massive earthquake. In many cases, local community serving organizations (CBOs) can provide an alternate safety net for these residents, but District 7 has disproportionately fewer CBOs than the rest of the City and many of its most vulnerable residents sit alone in their homes and grow more isolated and distanced from those around them every day.

The introduction of the NEN's ECP will help GWPNA reverse this trend of isolation and underpreparedness and increase the capacity of local agencies and organizations to work as a cohort to support the health and well-being needs of all residents before, during and after a disaster.

Resilient West Portal is seeking funding to craft and implement a resilience action plan that will advance the preparedness of the West Portal community at the individual, organizational and community levels. The funding will be distributed in the following manner:

- 1. Creation of a West Portal Resilient Action Plan (\$10,000) A key component of the NEN's Empowered Community Program is the creation of a resilience action plan. By starting with a blank slate and convening local stakeholders to participate in a facilitated process that generates goals and objectives that are customized to the unique needs of the West Portal community, GWPNA believes that more people will get involved in the activities necessary to increase our communities over all disaster preparedness. The planning process last approximately 4 months and involves multiple stakeholder meetings and workshops. In addition, the funding will cover free trainings and up to five organizations receiving technical support for updating their continuity of operations plans. At the end of the year, the community will participate in a tabletop exercise to test the skills and capacities they have developed. The \$10,000 will be used to retain a local non-profit disaster resilience consulting firm.
- 2. Acquisition of equipment to support a neighborhood emergency operations center (\$10,000) After a major disaster, such as an earthquake, West Portal can expect to be on its own for at least 72 hours before any professional first responder help will arrive. During this period, the neighborhood will need to meet the health and well-being needs of its residents on its own by setting up a neighborhood emergency operations center (NEOC). In addition to needing to set up a staging area that will most likely be outdoors and away from potentially damaged buildings, the NEOC will also need to be able to function with very limited, if any, access to electricity and standard communications systems (i.e. cell phones and landlines). The goal is to secure a similar suite of pop up shelters, solar powered generators and communication devices that the MPIC was able to secure for their staging area. The budget of \$10,000 will cover:
  - a. Pop-Up Tents and Accessories
  - b. Solar Powered Generators

- c. Walkie Talkies and Mesh Network Devices
- 3. Senior Preparedness Training and Kits (\$5,000) Everyone deserves the chance to increase their individual preparedness and GWPNA wants to provides its senior residents with free access to preparedness trainings that are customized for their needs as well as provide them with disaster kits that they can use to protect their health and well-being after a disaster. The funding (\$5,000) will be used to retain a non-profit disaster preparedness firm as well as disaster kits for seniors in the community.

The goal of the Resilient West Portal project will be to advance the preparedness of all members of the community.
